Rear of Clore Management Centre

T1 London Plane x 1 (Platanus x hispanica) This previously pollarded 18m London Plane tree within a Conservation Area, is located in a courtyard at the rear of the Clore Management Centre. The base of the tree is surrounded by air conditioning units. The base of the trunk has caused a boundary wall to crack and lean over toward the neighbours garden area. It is a matter of time before this wall collapses entirely. The trees canopy extends towards the surrounding buildings, touching windows and interfering with roof drainpipes and fire escapes.

Suggested work:- reduce all round by 2-4m back to original reduction points. This standard tree maintenance will slow root expansion. But the wall will need to be rebuilt around the trunk, allowing space for it to widen further.

- remove epi growth at the base and the detritus build up between the trunk and the wall

Rear of Clore Management Building

- T2 Sycamore x 1 (Acer pseudoplatanus) This 11m sycamore tree has not previously been pruned. The canopy now touches the neighbouring college buildings and interferes with the spiral staircase/fire escape. The base of this tree is surrounded by air conditioning units. Suggested work:
- reduce the height by 3.5m
- reduce the lateral growth by 3m, leaving furnishing growth
- remove deadwood

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

e.g. Oak (T3) - Whole crown reduction to 12m above ground level, to provide sufficient clearance to property.

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
  - o mark and name surrounding roads
  - o sketch in buildings, including adjoining properties
  - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - $\circ\;$  adding other relevant features on the site (e.g. greenhouse, paths)
