Proposed Work:

REAR GARDEN: 2 x Leyland Cypress Hedge (G3) - Reduce height by slightly more than 3m - 4m. Trim face by 0.5m - 1m to tidy, ensuring live growth is retained.  
1 x Holm Oak - Evergreen Oak (*Quercus ilex*) (T5) - Reduce height by 1m - 2m.

The Council has considered your notification of intended works to trees dated 26 May 2023 and does not wish to object.

from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
