T1 and T2 Ash -The trees are located in the rear garden of the property growing between the garage/outbuilding and the perimeter fence - tree has started to crack the back wall of the building and has also started to envelop the roof of the building which is made of Asbestos. The roof is currently intact but the tree is starting to put big pressure onto the roof sheets and there is a very big risk that the trees will crack the asbestos and release the fibres into the air. Fell both trees to ground level using lowering techniques to prevent any damage to the roofing sheets, during works the roof sheets underneath the working area will be covered with 12mm Ply Sheeting to prevent breakage and reduce the risk of damage to the Asbestos sheets

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
