Fell dead cherry (T1) and cut to ground level. Reduce crown by 2m on all aspects of purple plum (T2). This is to take weight out of crown as there is a split in the stem and decay at base.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
