T1 London Plane Large mature tree, reduce lateral limbs back into most recent previous pruning points 2 M approx., thin density by 20%, and remove deadwood. Aerial inspection of crown, retain basic size, shape tree as necessary

T2 London Plane Large mature tree, reduce lateral limbs back into most recent previous pruning points 2 M approx., thin density by 20%, and remove deadwood. Aerial inspection of crown, retain basic size, shape tree as necessary

T3 Holme Oak Reduce lateral and vertical growth by 2-3 M approx. (30% crown reduction in size), remove deadwood

G4 Group Holly Reduce lateral and vertical growth by 2-3 M approx. (30% crown reduction in size), remove deadwood

T5 London Plane Reduce back by 2M approx. to clear street light

T6 London Plane Lift to clear road and footpath by 5.5 M

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - $\circ\;$ showing the approximate distance between the application tree(s) and buildings
 - $\circ\;$ adding other relevant features on the site (e.g. greenhouse, paths)
