Acacia - This tree has some decay at the base and in the main trunk on the east side at approx. 3.5m (just below the main fork)  Reduce the height by 4-5m  Reduce the crown spread by 3-4m
Reduce the extremities of the branches growing towards and over the house to give a clearance of 2-3m
