Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Rear Garden:

T1: Mature Pittosporum - (overhanging from Follie House, East Heath Road): Approximately 7.00m. Reduce overhanging branches by approximately 1.50m.

T2: Mature Magnolia: Approximately 7.00m. Thin upper crown density by approximately 15%. Reduce vertical and sub lateral growth in the upper crown section by approximately 1.00m.

T3: Acer: Approximately 4.00m. Reduce crown by approximately 1.00m. Thin upper crown density by 20%. Preserve low shoots.

G1: Group of 3 x Irish Yew: Approximately 6.00m. Reduce heights as required by up to 0.75m to obtain a more uniform height for the three trees. Remove Rose from first tree.

T4: Mature Birch - (rear boundary): Approximately 11.00m. Thin crown density by 15-20%. Reduce back from neighbouring property by 1.00m. Reduce overlong extraneous growth back into main crown structure (up to 1.25m) to separate from the adjacent Birch and preserve a compact crown structure.

T5: Larger Birch: Approximately 12.00m. Reduce overlong branches back into main crown structure (approximately 1.25m). Thin crown density by 15-20%. Reduce to separate from T4 (up to 1.25m).

S2: Griselinia: Approximately 5.00m. Reduce back to previous reduction points.

G2: Group of Mature Magnolia Grandiflora: Approximately 7.00-8.00m: Reduce height of group by pruning overlong vertical shoots back into main crown structure approximately 0.50m. Reduce lateral and sub lateral growth by approximately 1.00m to control encroachment and maintain as a formal hedge line.

T6: Large Bay: Approximately 7.00m. Reduce back to previous reduction points or beyond up to approximately 1.50m if practicable.

T7: Small Bay: Approximately 3.50m. Reduce by approximately 1.00m back into the natural hedge line formed by mixed species climbing plants on the fence line. The tree is to be shaped with a natural crown line.

T8: Mature Cherry: Approximately 14.00m. Thin crown density especially on the north east stem by approximately 20%. Reduce extraneous branches back into main crown structure where required to maintain a compact yet natural crown line (up to 1.25m). Remove dead wood throughout crown.

Reasons: General maintenance unless otherwise specified.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements).

- Tree species
- The number used on the sketch plan; and
- A description of the proposed works.

Where trees are protected by a Tree Preservation Order you must also provide:

- Reasons for the work; and where trees are being felled
- Proposals for planting replacement trees (including quantity, species, position and size) or reasons for not wanting to replant.

e.g. Oak (T3) – Whole crown reduction to 12m above ground level, to provide sufficient clearance to property.

Sketch plan requirements

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
