T2 - Sycamore Tree - Reduce all round by 4-5m, remove major deadwood. To reduce the size of the tree which has outgrown its space within the garden. To reduce the extent of damage to garden wall. To allow more light into surrounding property's due to excessive shading.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
