### **NO OBJECTION TO SECTION 211 NOTICE OF WORKS TO TREE/S IN A CONSERVATION AREA**

Proposed Work:

REAR GARDEN: 1 x Mimosa (T1) - Reduce the height by 20%, approx. 2m. Reduce the crown spread to balance and shape, approx. 1.2m - 1.5m.

1 x Magnolia (T2) - Thin throughout the crown by 25%. Reduce the large branch over the garden by 15% - 20%, approx. 1m - 1.2m. Reduce stem growing towards house by 20%, approx. 1.2m - 1.5m. Remove selective low branches over the neighbour's garden (see photo).

The Council has considered your notification of intended works to trees dated 07 June 2023 and does not wish to object.

Informative(s):

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.
- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.

- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife. Of particular note is the protection offered to bats, birds and their nests from construction works.
