T1 Lime - Reduce crown to points of previous reduction. Reduce stem growing towards 94 SHP roof by a further 1m Prune to clear both properties by 1-1.5m Crown lift to 6m from ground level

Reasons for work- this tree is growing in very close proximity to the houses and the boundary wall and is causing problems with blocked drains at number 94 SHP.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
