My concerns include:</p> <ul style="list-style-type: none"> <li>- the significant size of the pole, taller than many of the buildings, trees and lampposts surrounding and inevitably obstructing the view for many</li> <li>- mast and multiple cabinets would be sited right outside Hampstead cemetery, reducing access to this local amenity, especially by residents and carers of the residential home across the road</li> </ul> <p>Any work/repairs required on these cabinets/masts will require temporary traffic lights or vans on the side of the road and this will further add to the road dangers/child safety issues and would impede the pedestrian movement.</p> <p>Additionally, I am concerned about the lack of long-term studies of 5G exposure on children, pregnant women and individuals with compromised immune system - in particular as the proposed site is very close to a nursery school, tutoring academy and sporting grounds of a large local school. The Council should consider their legal liability in the event of future health claims following the huge number of objections from locals.</p>

Erection of an 18m high telecommunications pole and 3 x equipment cabinets.</p> <p>I strongly object to this application.</p> <p>I am a frequent visitor to the area. I visit Hampstead Cemetery and I have friends who live close by.</p> <p>The plans are defective because I cannot even understand some of the documents they are not in layman's terms. For example, when I open up this (see screen shot below), it just shows an indecipherable list. Site photograph of where mast located very small and very poor quality. Unable to see it properly. No indication of where the mast will be located in that site photograph e.g., before and after images. The height of this monopole will impact on the visual amenity of the area. It will interrupt the skyline and aesthetically it will be very unattractive. It will be an eyesore for anyone visiting the cemetery or friends who live close by.</p> <p>I visit the cemetery frequently and have friends in the area. I am very concerned for my health should this monopole be installed. I fully accept that it is not the role of the planning officers or the councilors on the planning committees to consider the health risks, nor to consider the validity of health issues or their personal beliefs in those issues. However, it is their responsibility to consider the vast amounts of new research pointing to serious health implications affecting the lives of residents near to mobile phone masts. It is clear that worrying about the implications to one's health from mobile phone masts, especially if the mast is 5G which has caused many concerns lately and it is going to be situated close to one's home.</p> <p>There are residents for whom, just by reason of the proposal of a 5G mast, will suffer from extreme anxiety. It is the perceived health risk which will cause loss of amenity irrespective of whether the danger is perceived or real. These ill effects will be intensified if the application was to be approved. Camden has a duty of care for all its citizens.</p> <p>The proposed development, by reason of its scale, design and siting, at high level in a prominent location, would result in visual clutter which would be detrimental to the character and appearance of the host building and the street scene.</p> <p>The cabinets on the site would create a visual obstruction to nearby residents, causing an undue sense of enclosure and harming outlook, contrary to policy A1 of the Camden Local Plan 2017.</p> <p>The siting of the cabinets appears to be near a public highway crossing. They would cause obstruction to anyone with mobility problems such persons with disabilities or parents with small children in pushchairs. This is a public footpath and the cabinets on the footpath would cause a loss of amenity to people.</p> <p>The siting of the mast will be overbearing and detrimental to the setting of Hampstead Cemetery which is rich in heritage and was opened in 1876. Many members of the public visit this cemetery and the cabinets and the mast will be a complete eyesore.</p>

I object to this 18 meters high telecommunications pole as it is higher than the precedent proposals and will definitely be an eye sore in a beautiful area, with striking architectural heritage. The Hampstead cemetery is also opposite, and it would be a shame to build a large pole very close to its entrance. I have basic internet provision through one of the UK's largest providers and although I work from home have never faced any wifi or other coverage issues, etc, so not sure how much better coverage I can get from this unwarranted addition, unless I was mining bitcoins in which case maybe I'd be interested. There is a lot of rare wildlife in the nearby cemetery such as birds (lesser spotted woodpecker, green woodpecker, etc) and I'm not sure there are any plans to evaluate the impact of an 18 meters telecommunications pole on nesting and feeding habits of protected UK species. Fortune Green Road is quite a busy road and I'm not sure building 3x equipment cabinets next to a high mast is the best idea as it will take up a lot of space and the pavements are quite narrow in the area. It will further congest an area that can very congested by traffic in the late afternoons.
