Ash (T1) - Reduce lateral branches by up to 2.5m, to create a narrower more upright canopy. All the lateral limbs are very overextended with significant end weight. Some branches have failed in the past few weeks during dry still weather. The work will reduce chance of limb failure, and let more light into the garden.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - o showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)
