T1: Leyland Cypress - Fell to ground level and grind out stump

Justification: loses boundary hedge, inappropriate in unmanaged form

T3: Cherry - Fell to ground level and grind out stump. Removal to facilitate replacement planting

Justification: small / ornamental

T4: Magnolia - Fell to ground level and grind out stump

Justification: tree is declining / dying with live foliage chlorite. Removal to facilitate replacement planting

T8: Apple - Fell to ground level and grind out stump

Justification: to facilitate replacement planting

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - $\circ\;$ adding other relevant features on the site (e.g. greenhouse, paths)
