Reduce height from 18m to 15m (window level of 2cnd floor flat), balance upper canopy edges to provide 3m clearance from property's front elevation. Prune back from street light to give 1m clearance.

 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
