1.0 Introduction

Potter Raper are working alongside Wates to facilitate the replacement of building elements on properties, on behalf of St. Mungo's Charity.

This design and access statement will support the planning application for the development of the premises 83 Endell Street, Camden, WC2H 9DN.

2.0 Existing Premises

The building in question is a residential block characterised by brick façades with a mixture of red and yellow brickwork. The building is comprised of five storeys and is a building of multiple occupancy.

2.1 Planning Restrictions

The building is location within Seven Dials conservation area, and is a Grade II listed building.

3.0 Design Proposals

3.1 Existing Roof

The roof of the building is not visible from ground level, however does retain it's original slate roof coverings.

The existing roof coverings are no longer meeting the needs of the residents living in these properties and are leading to defects.

3.2 Proposed Roofs

It is being proposed that the roof coverings are removed and replaced with like-for-like materials to ensure the character of the building is retained in all aspects.

4.0 Car Parking/Transport

Parking in the area is limited, with a small amount of residents parking on Endell Street. Most transportation will need to be via public transport, of which there is plenty. This includes the use of Buses and Cabs/Taxis in the area. The nearest Tube stops are Covent Garden, Holborn, and Tottenham Court Road which all both nearby.
