2. East elevation (facing No.1) addition of 2no. windows and 1no. door at lower ground floor level, omission of 1no. window at ground level and addition 1no. window at first floor level.
3. West elevation (facing No.3) addition of 1no. window on half landing ground to first floor (fixed shut and frosted) plus retention of existing window at lower ground level.
4. Removal of side steps from ground floor terrace and adjusting of level to external side passage (alongside No.1) to allow for new side door.
5. Front elevation at first floor level in red brick rather than render.
7. At roof level 2no. dormers to have lead not tiled cheeks plus inclusion 1no. skylight over staircase.
8. Side path retained at lower level to allow for new side door.
