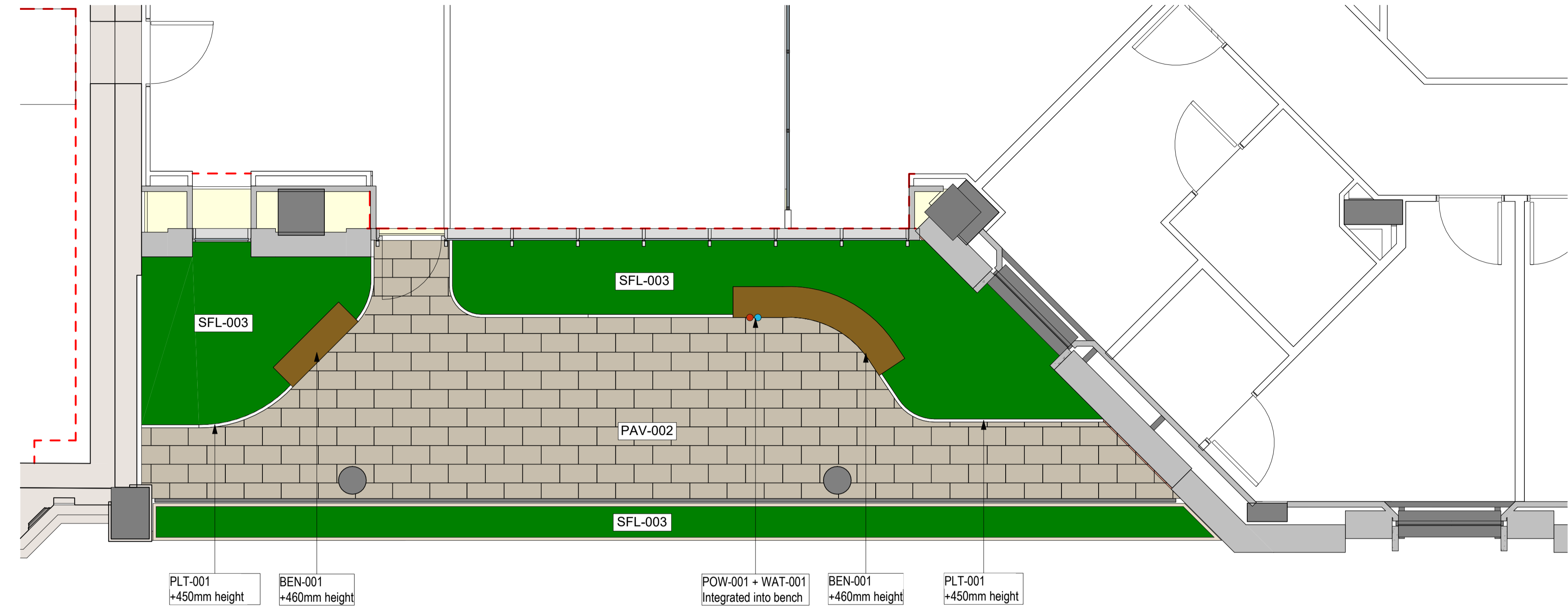


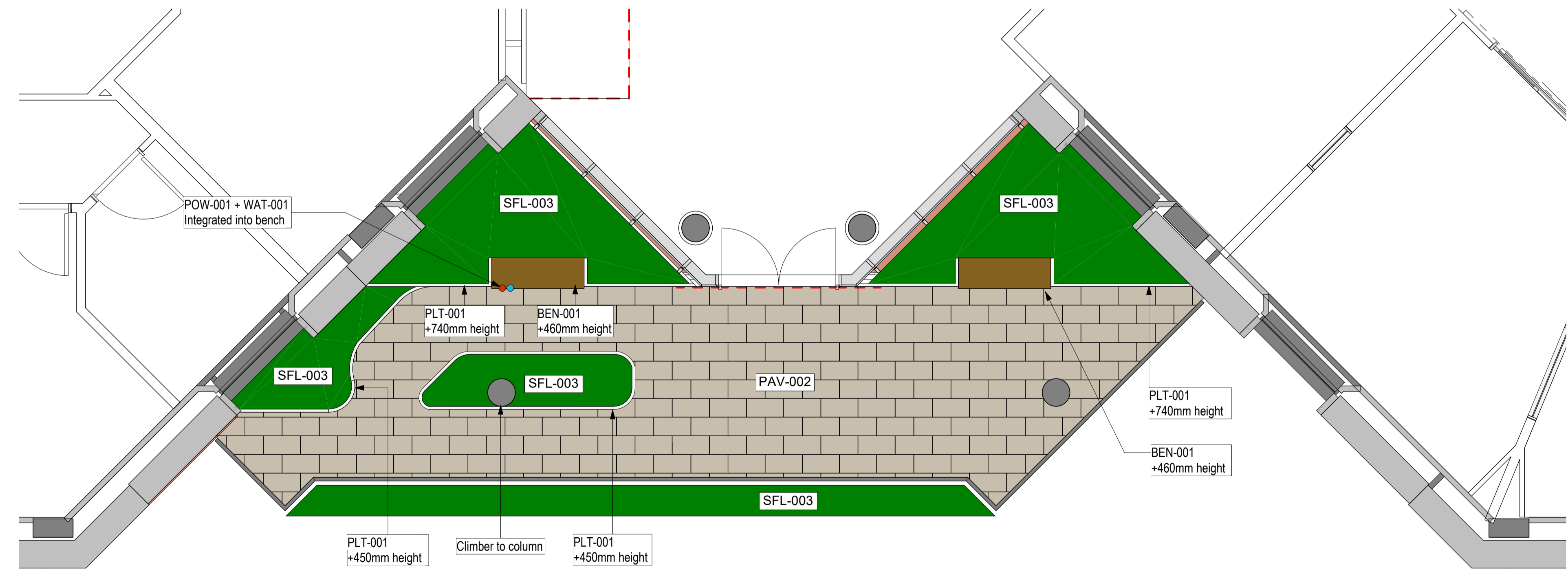

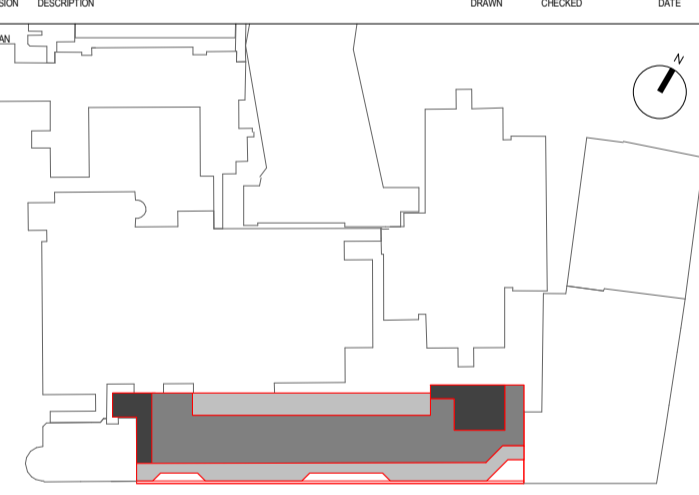


1 Level 4 Staff Balcony West
