Work Required - To Prune all round by removing 1-2m back to previous growth points

Location - Rear garde

Service - Prune

Work Required - Reduce crown all round by removing 1-2m pruning to suitable growth branch/fork junction

Reason - As part of continued maintenance

Tree Type - London Plane (Platanus x hispanica)

Approx. Crown Spread Diameter - 12m

Location - Front of property

Service - Repollard

Work Required - Re-pollard back to previous pruning points by removing approximately (2-3m) from height and (1-2m) lateral growth, to include removal of all epicormic and basal growth

Reason - As part of continued maintenance

Tree Type - unidentified

Approx Height - 3.5m

Approx Spread - 2

Location - Front garden

Service - Fell

Work required - Fell as close to tree's current ground level as possible and leave the stump in the ground.

Reason - dead tree.

Tree Ownership

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - o mark and name surrounding roads
 - o sketch in buildings, including adjoining properties
 - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
