Details of the pre-application advice received

The Council supports the principle of the proposed development, subject to revisions and additional information based on the comments outlined above. These include revisions to the lower ground floor front entrance, additional information on the design of the rear extension French doors, and reducing the height of the replacement outbuilding alongside reconsidering its siting to allow for a gap between the boundary and the outbuilding. In addition, the use of green roofs are very encouraged within the development. An arb report would be required to make an assessment on the impact of the development on the trees. An existing and proposed block plan would also be required.
