Tree location - front garden

T1 - Approx. H14+ S10 60+DBH - Copper Beech

Crown reduce height by approx. 1-2m

Reduce laterals by approx. 2m, pruning back to suitable secondary growth to form a smaller neater canopy

T2 - Approx. H10 S5 30DBH - Chinese Privit (located in frontage of

no. 9)

Reduce lateral growth that encroaches across frontage of no. 7 by approx. 2m

Tree work is to be undertaken to remove dead branches to improve form and increase safety in accordance with good arboriculture practice and maintain the future well being and growth of the trees.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
