Please identify the tree(s) and provide a full and clear specification of the works you want to carry out T4 False Acacia & HG1 Mixed spp. hedgerow group of mostly Rose, Pittosporum, Holly and Bay of MWA Arb Report Works: T4 False Acacia - Remove (fell) to near ground level and treat stump to inhibit regrowth. HG1 - Mixed spp. hedgerow group of mostly Rose, Pittosporum, Holly and Bay - Reduce height to 2.0m and cut back sides to leave no wider than 1.0m. Trim thereafter on an annual cycle to maintain at broadly reduced dimensions. Reason: Clay shrinkage subsidence damage at neighbouring property 138 Haverstock Hill, NW3 2AY. You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work. Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available.
