Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1 Ash

Tree has recently suffered large limb failure over adjacent bridge causing serious damage. Limb failed over a pedestrian footpath and onto high traffic road. The resulting damage to the tree is a large tear out at 6m on secondary leader to the NW. Tree is twin stemmed specimen with bifurcation at 2m. Extensive ivy growth enveloping remaining canopy. Visible canopy is sparse and showing signs of dieback.

T2 Sycamore

Tree is growing over adjacent footpath/highway. Heavy ivy cover. Encroaching statutory clearance. Recommend sever ivy at the base and allow to die off. Lift to provide statutory clearance over footpath (3m) and road (6m).

T3 Ash

Part of a group of 3 ash trees (southern tree).

Group are old pollards at around 10m. Slightly sparse canopies with varying degrees of dieback.

T3 has large basal wounds on south and east. Cavity at 6m. There were 3 inonotus hispidus brackets around the base of this tree. Unable to ascertain their start point.

Recommend fell to ground level.

T4 Ash

Part of a group of 3 ash trees (central tree).

Group are old pollards at around 10m. Slightly sparse canopies with varying degrees of dieback.

T5 has wound on west at 2.5m and cavity on west at 4m. Dense regeneration from pollarding. Encroaching footpath, highway and road sign. Recommend fell to ground level. If tree retention is valued this could possibly be reduced back to original pollard points by removing 5m height and 3m spread over road.

T5 Ash

Part of a group of 3 ash trees (northern tree).

Group are old pollards at around 10m. Slightly sparse canopies with varying degrees of dieback.

T5 is a twin stem tree with evidence of multiple historic reductions. Minor deadwood throughout and encroaching statutory clearance over footpath.

Recommend remove deadwood. Lift to provide 3m clearance over footpath. Reduce remaining canopy by 3m height and spread.

Reason for recommended works

Health & Safety due to condition and locations of the trees

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - o sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - $\circ\;$ marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
