IN PARK GROUNDS: 1 x Crimson King (Acer platanoides) (T32) - Prune back from building 2m clearance, lift crown to 3m.
1 x Taxus baccata (T33) - Prune back from building 2m clearance, lift crown to 3m.
1 x Crataegus monogyna (T278) - Prune back from building 2m clearance, lift crown to 3m.
1 x Salix fragilis (T277) - Prune back from building 2m clearance, lift crown to 3m.
1 x Prunus kanzan (T37) - Prune back from building 2m clearance, lift crown to 3m.
1 x Taxus baccata (T39) - Prune back from building 2m clearance, lift crown to 3m, prune away from light 1m clearance.
1 x Taxus baccata (T46) - Prune back from building 2m clearance, lift crown to 3m, prune away from light 1m clearance.
1 x Ilex aquifolium (T49) - Prune back from building 2m clearance, lift crown to 3m.
1 x Quercus robur (T52) - Prune back from building 2m clearance, lift crown to 3m.
1 x Taxus baccata (T51) - Prune back from building 2m clearance, lift crown to 3m.
1 x Prunus cerasifera 'Nigra' (T55) - Prune back from building 2m clearance, lift crown to 3m.
1 x Taxus baccata (T57) - Prune back from building 2m clearance, lift crown to 3m.
1 x Populus nigra 'Italica' (T60) - Remove epicormic growth. Cut back from building 3m clearance.
1 x Populus nigra 'Italica' (T61) - Crown reduction by 30%, 5m.
1 x Populus nigra 'Italica' (T63) - Remove epicormic growth.

The Council has considered your application dated 07 June 2023 and decided to grant consent subject to the following condition(s):

Conditions and Reasons:

- 1 This decision is valid for 2 years from the date of this decision or until the work is completed, whichever is the sooner.

Reason: To allow the Local planning authority to monitor the completion and standards of the work.

- 2 All work shall be carried out in accordance with the relevant recommendations of British Standard 3998: 2010. (Recommendation for Tree Work)

Reason: To ensure the preservation of the amenity value and health of the tree(s).
