NO OBJECTION TO SECTION 211 NOTICE OF WORKS TO TREE/S IN A CONSERVATION AREA

Proposed Work:

WITHIN SCHOOL GROUNDS: 1 x Silver Birch (T2) - Fell to ground level.

1 x Ash (T5) - Crown reduction height and spread 3m - 3.5m branch lengths.

3 x Lombardy polars (T23, T27 & T29) - Reduce height 5m - 6m to reduce over-extended form and shape to balance.

1 x Horse Chestnut (T28) - Fell to ground level.

1 x Cherry (T47) - Crown reduce height/spread branch lengths of 3m - 3.5m. Crown lift to 4m.

1 x Horse Chestnut (T53) - Reduce height by branch lengths of 4.5m - 5m, spread by 3m - 3.5m.

1 x Larch (T93) - Fell to ground level.

1 x Cherry (T102) - Crown reduce height and spread 3m - 4m branch lengths. Crown lift to south by 5m.

The Council has considered your notification of intended works to trees dated 12 June 2023 and does not wish to object.

- 1 This notice is valid for 2 years from the date of this letter or until the work is

completed, whichever is the sooner.

- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.
- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
