T1 Silver Birch x . (Betula pendula / alba) This tree is due its cyclical prune - Reduce the height back to the previous points of reduction which approximately equates to 2m - reduce the lateral growth also back to the previous points of reduction to blend with the upper crown which equates to 1.5-2m whilst retaining as much internal and furnishing growth as possible.

Front (1)

T2 Magnolia x . (Magnolia spp) This tree is also long overdue its cyclical prune - Reduce the height back to the previous points of reduction which equates to 2-2.5m from the height and the lateral growth which will also equate to 2-2.5m - retain internal and furnishing growth.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
