T1 - pyracantha tree (4m) - trim with hedge cutters by up to 50cm.	
T2 - yew tree (7m) - reduce height by approximately 3m and remove six of the lowest branches to lift crown.	
T3 - yew hedge (2.5m) - reduce height by approximately 0.3m and trim front and back with hedge cutters.	
T4 - birch tree (5m) - reduce width of crown by approximately 0.5m, making sure that it doesn't cross the boundary with #50 and reduce branches growing from top of crown back down to weeping shape.
