Tree location - front and rear garden

T1 - Approx. H15 S7 30DBH Liquidambar Crown thin 15% removing major deadwood. Lift to 4m (5m over road).

T2 - Approx. H5 S4 15DBH 2x Magnolias Crown reduce height by approx. 1.5-2m (regrowth) Prune to shape.

GRP1 - Approx. H16 S5 25+DBH Mixed trees, Prunus etc. Elder (in adjacent garden) Cut back/prune all regrowth that encroaches across no. 24 back to boundryline as per previous practice.

T3 - Approx. H4 S2 15DBH Maple Remove major deadwood. Lightly pole snip extremities to form a neater specimen.

T4 - Approx. H6 S3 15DBH Pittosporum Crown reduce height by 2m Lightly tip prune laterals by 0.5m to form a neater specimen.

T5 - Approx. H3 S2 10DBH Pineapple shrub Reduce height by 1.5m Remove deadwood T6 - Approx. H2 S1 10DBH Hazel Recoppice

T7 - Approx. H16 S6 35DBH Tulip tree Crown reduce height only by 3-4m Remove major deadwood.

GRP2 - Approx. H16 S5 30+DBH Mixed Conifer and Prunus etc. in adjacent garden Cut back/prune all regrowth that encroaches across no. 24 back to boundary line as per previous practice.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

  - mark and name surrounding roads

  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - $\circ\;$  marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
