## Conditions and Reasons:

Between November 2023 and March 2024, a single-stemmed downy birch (Betula pubescens) shall be planted within 1m of the location of the application tree no less than 750mm from any structure unless otherwise agreed with the council in writing. The tree shall be 12-14cm in circumference at 1m above the rootplate. The tree shall be planted and maintained in accordance with BS8545:2014.
