CANAL REACH (SEE PLAN TLP-14): 12 x Pin Oaks (*Quercus palustris*) (T380 - T391) - Lift crown to give 5m ground clearance over roadside and 2.5m over footpaths, targeting secondary growth where possible.

The Council has considered your application dated 27 July 2023 and decided to grant consent subject to the following condition(s):

Conditions and Reasons:
