Identification of Tree(s) and Description of Works

Contorted Willow T1

Remove and replace with suitable ornamental tree species to be agreed with LB of Camden suggested species Prunus 'Amanogawa' or Ligustrum spp,

The willow tree is growing in a raised planter, the main trunk at 1.6m above the level of the raised planter is within 10mm of the listed wall, when the tree moves in the wind the trunk is exerting direct pressure onto the wall the stone plinth on top of the wall has been displaced and cracks are observed in the wall. The radial growth of the trunk will reduce the clearance between the trunk and the wall and will increase the pressure on the wall & plinth. This will also serve increase the loading caused by the trunk moving in the wind. This continuing direct damage to the listed wall is unavoidable and this damage will worsen as the tree trunk continues to grow. Height reduction of the tree will not prevent the radial growth of this fast growing tree, the tree will respond to reduction works by producing prolific regrowth which will not serve to prevent movement in the wind.

Please note the removal of this tree is not due to direct damage to the lower planter but due to the risk of continued damage to the listed wall that forms the raised back of the planter.

The boundary wall is Listed given it forms part of Primrose Hill Studios, which is a Grade II Listed. (#1390876) The wall forms part of the third-party property. An email from the 3rd party is included in this application.

It should be noted that removal of a tree to abate an actionable nuisance (to a third party) is exempt from requiring a TPO consent, however we would prefer that this matter is agreed with the LB of Camden prior to any tree works being undertaken.

Historically the planter around the base of the tree has been filled with bedding plants which have been continuously irrigated, this is considered to be unsustainable and new drought tolerant planting is proposed, the cessation of the irrigation will impact on the growing conditions for this willow which is considered to be a high water demanding species of tree.

The request for evidence generally relates to subsidence (indirect) damage where trial pits, foundation depths, soil analysis, root identification, seasonal movement are all required to implicate a tree as a contributory factor in structural damage. This case relates to direct damage so the information listed is not relevant to this application, unfortunately due to low level vegetation it is difficult to get a photograph showing the proximity of the tree trunk to the wall, we are happy to meet on site to allow access up onto the planter to view proximity of the tree trunk to the wall.

It is my opinion that this tree has a low amenity value and makes a very limited contribution to the character & appearance of the Conservation Area, the proposed replacement planting will serve to mitigate the impact of the proposed removal.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
