The tree is not desirable for retention as it is growing out of and disrupting flagstones, and the crown is in close proximity to windows.

 - $\circ\;$ showing the approximate distance between the application tree(s) and buildings
 - $\circ\;$ adding other relevant features on the site (e.g. greenhouse, paths)
