T1: Mature Lime - Approximately 19.00m. Reduce crown back to previous and most recent reduction points whilst preserving a suitable amount of reduced furnishing growth to ensure crown continuity and help preserve screen (approximately 1.50-2.00m reduction all round). Thin crown density by approximately 20%. Raise low epicormic growth by approximately 1.25m. Thin remaining epicormic growth in main stem by approximately 20%.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Reason: General maintenance.
