To fell to the ground a mature (and nearing the end of its life) 20 metre tall, 16 metre diameter Copper Beech (Fagus sylvatica f. purpurea) tree in the back garden. It substantially overhangs the garden of 1 Brookfield Park and the access road of La Sainte Union School. It is a very large non-native woodland tree unsuitable for this small urban space. It would be replaced with a native fruit tree more suited to the space. We plan to grind the stump down.

It is marked as T1 on the sketch and is the red/purple tree in the photos.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
