Bay (T1) - Fell and cut stump to ground level. There is extensive decay at the base of the tree, indicated by a large Ganorderma bracket. There are vertical cracks running down the main stems and the crown is very thin.
Hawthorn x2 (T2, T3) - Reduce crowns back to previous cuts (1.5m off). To let more light into the property and restrict root growth.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
