# Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T30 Silver Birch (x1) - Fell to ground level. Reason: Leaning and suppressed by T31 Beech. Swamped with creeper. T31 Copper Beech (x1) - Reduce the lateral branches of the upper crown which overhang the garden of Flat 1, 26 Glenloch Road by 2m. Reason: So it no longer overhangs the conservatory and is maintained at a smaller size.

T37 Robinia (x1) - Remove x3 low branches and deadwood through crown. Reason: General maintenance. To maintain the tree at a smaller size.

T46a Ash (x1) - Fell to ground level. Reason: Tree is self-seeded.

T49 Norway Spruce (x1) - Fell to ground level. Reason: Creating excessive shade / darkness in the area and growing into crown of T50 Robinia.

T50 (x1) - Robinia pseudoacacia 'frisia' (x1) - Remove dead branches in lower crown. Reason: General maintenance. To maintain the tree at a smaller size.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

  - mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - $\circ\;$  marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
