1. S73 app:

I've just taken a look at what was submitted – it does not appear that you put forward a 'Non-Material Amendment' to the description of the parent proposal to include the air intake fan. This would be required as you did not initially acquire consent for these particular works. However, I've had chat with my managers – in order to simplify this complex matter (in-line with my advice dated 30.08.23) and particularly in regard to Nathan's concerns [see below schedule 2], please re-submit the form (and pay the difference if there is one) so that the proposed works (including the air intake fan) will be assessed through a SEPARATE planning application.

2. \*Holding in abeyance prosecution action (in connection with the Breach of Conditions Notice dated 15th August 2023):

We have noted your concerns regarding the compliance date and have decided, subject to the above request, that we would hold in abeyance prosecution action whilst the separate planning application is being determined. You can then discharge the post-implementation conditions after a decision.
