Rear Garden:

- T1: Multi-stemmed Cotoneaster: Approximately 6.00m: Reduce crown height by up to 1.00m. Reduce lateral and sub lateral growth by up to 1.20m by means of reducing overlong extraneous branches back into main crown structure. Thin crown density by approximately 20%. Remove major dead wood throughout crown. General maintenance.
- G1: Row of semi-mature Hornbeams: Approximately 8.00m: Growing close to the boundary wall: Reduce crowns by up to approximately 1.50m all round, reducing overhanging branches back from neighbouring property. Control encroachment. General maintenance.
- T2: Mature Pear: Approximately 8.00m: Remove dead wood throughout crown. Thin crown density by 15%. Reduce overlong extraneous back into main crown structure not more than 1.00m. Basal decay is present. General maintenance.
- T3: Laurel: Approximately 5.00m: Partially suppressed. Reduce by up to 1.20m to shape and encourage crown density. General maintenance.
- T4: Pittosporum: Approximately 3.50m: Trim to tidy ,reduce by 0.75cm.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o mark and name surrounding roads
 - o sketch in buildings, including adjoining properties
 - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
