IN GROUNDS SEE PLAN: 4 x Silver Maples (T2, T3, T4 & T6) - Crown lift to 5m & crown clean.

- 1 x Silver Maple (T5) Crown lift to 5m & crown clean removing crossing branch.
- 1 x Silver Maple (T7) Crown lift to 5m & crown clean removing small hanging branch.
- 1 x Silver Maple (T8) Crown lift to 5m including removal of 1 x lateral to southwest at 5m back to main leader. Crown clean removing small hanging branch.
- 1 x Silver Maple (T9) Crown lift to 5m including removal of 3 x 50mm 75mm diameter branches back to main leader. Crown clean.
- 1 x Silver Maple (T10) Crown lift to 5m. Prune eastern leader (lowest) by up to 3m branch lengths to give clearance from building.
- 1 x Silver Maple (T11) Crown lift to 5m Prune northeastern leader (lowest) by up to 3m branch lengths to give clearance from building. Crown reduce upright southeast leader towards building by 2m 2.5m branch lengths to balance. Crown clean.
- 1 x Silver Maple (T12) Crown lift to 5m & Crown clean. Prune eastern crown by up to 2m branch lengths to give clearance from building.
- 1 x Silver Maple (T13) Crown lift to 5m including removal of smaller sub 100mm diameter branches. Prune eastern crown by up to 2m branch lengths to give clearance from building. Crown clean.
- 1 x Silver Maple (T14) Crown lift to 5m & Crown clean.

- 1 x Ginkgo (T17) Crown lift to 2.5m.
- 1 x Red Oak (T19) Crown lift to 4m.
- 4 x Crab Apples (T24-T27) Crown lift to 2.5m height. Prune to give 0.5m clearance from structure to north.
- 4 x Honey Locusts (T48-T51) Crown lift to 3m pruning 25mm branch diameters only.
