T2 - Approx. H19 S13 60+DBH 2x Sycamores Crown thin 20% removing major deadwood. Crown lift to 5m

T3 - Approx. H17 S9 70+DBH Chestnut Remove trunk growth to crown break. Thin 20% removing deadwood. Lift 5m Cut back from building.

#### GRP1

Approx. H10 S8 20DBH Thorn Crown lift over roadway and footpath to 5m to comply with Highway Regulations. Approx. H15 S8 60DBH Lime Crown lift over roadway and footpath to 5m to comply with Highway Regulations Approx. H11 S8 40DBH Oak Crown lift over roadway and footpath to 5m to comply with Highway Regulations. Approx. H17 S10 60DBH Acacia Crown lift over roadway and footpath to 5m to comply with Highway Regulations. Approx. H17 S10 60DBH Acacia Crown lift over roadway and footpath to 5m to comply with Highway Regulations. T4 - Approx. H20 S15 100DBH Chestnut Remove trunk growth to crown break. Thin 20% removing deadwood. Lift 5m Cut back from building.

#### GRP2

Approx. H15 S8 40DBH Lime Crown lift 3m over path and 5m over road Approx. H12 S5 30DBH Lime Crown lift 3m over path and 5m over road Approx. H20 S15 80+ DBH Plane Crown lift 3m over path and 5m over road Approx. H5 S4 20DBH Thorn Crown lift 3m over path and 5m over road Approx. H4 S2 20DBH Cherry Crown lift 3m over path and 5m over road

Tree work is to be undertaken to remove dead branches to improve form and increase safety in accordance with good arboriculture practice and maintain the future wellbeing and growth of the trees.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - $\circ\;$  marking all trees on the plan, but only numbering those to which you want to carry out work
  - $\circ\;$  showing the approximate distance between the application tree(s) and buildings
  - $\circ\;$  adding other relevant features on the site (e.g. greenhouse, paths)
