Front of house:

Beech T1 (18M high, 750mm dia.) - overhangs roof and front windows of the property. - reduce the crown of property side by up to 3 metres to clear roof and windows.

Rear garden area:

Hornbeam T2 (15M high, 400mm dia.) - wide spreading low crown. - remove 3 lowest laterals on south side and draw in crown all around by up to 2 metres.

Holm Oak T3 (15M high, multi-stemmed) - raise south side of crown by 2 metres and balance remainder.

Leyland Cypress x 16 hedge G1(18M high, 400mm av. dia.) - completely overgrown hedge. - reduce height of all trees by up to 4 metres and face in garden side by up to 0.5/1 metre

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements).
