The proposed works consist of:

- · replacement of front windows and balcony door on the second floor; and
- replacement of rear windows and rear door on the ground floor.

The application is for the replacement of existing timber framed windows and doors with new timber framed double glazed windows and doors. Currently, there are cracks in the existing windows and difficulty closing the existing doors, hence the urgent need to replace these as soon as possible for security reasons. In addition, from an efficiency and environment perspective, the double-glazing will improve thermal performance.

The proposed windows and doors will match the style of the existing windows in all material respects. The only deviation being the replacement of the leaded panes in the top part of the rear ground floor windows with unleaded glass. This change is in keeping with other properties in the area and would not be readily visible from the public realm in any event.
