T1- horse chestnut at approx 20M. Requesting a heavy reduction. Has been reduced but requires TPO. Requesting heavy reduction of 40% approx 8M round. The resident is requesting a heavy reduction to allow time between regrowth. Tree has grown well due to good up keep and requesting slightly more on this reduction. If we are not able to get 40% please allow the maximum cut back for this particular tree and location
