FRONT GARDEN: 1 x Gleditsia - Reduce crown to previous and regular points of reduction (2.5m, 20% approx.), crown lift to 5m from ground level, prune clear of building by 2m. Reason for work - regular routine maintenance to prevent encroachment onto the roadway or the building

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

  - $\circ\;$  showing the approximate distance between the application tree(s) and buildings
  - $\circ\;$  adding other relevant features on the site (e.g. greenhouse, paths)
