

6.0 DESIGN PROPOSALS

6.01 PROPOSED WORKS DESCRIPTION

- The applicant wants to create a mixed-use development consistent with the character of the local area.
- Pub floorspace would be re-provided on the ground floor, facing the pavement, to create an active street frontage.
- High quality residential accommodation is proposed on the upper floors, benefitting from private amenity space, with large window openings allowing daylight into the rooms.
- An additional floor is proposed to mimic the building forms in the immediate area of the site. This is set back from the facade to appear hidden at street level but to still benefit the housing mix.
- The existing facade features a painted blue ground floor and white render above, which is considered to be of poor quality following unsympathetic works in the 20th Century. The client intends to propose a high quality building of architectural merit. The materials have been carefully chosen to reflect the existing condition, whilst bringing more value to the prominent corner public house condition, with key details taken from historical and local references.
