DD 5 Day Notice REAR GARDEN: 1 x Sycamore (T1) - Fell to ground level.

Thank you for your letter/telephone call of 21 September 2023 giving notice that the above tree(s) are considered dead/dying /dangerous and require emergency works.

The Council confirms that the remedial works as described above are exempt from the need for further notifications or any formal application to the Council and you are therefore allowed to proceed.

Informative(s):

- 1 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.
- 2 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife. Of particular note is the protection offered to bats, birds and their nests from construction works. For further information contact Natural England on 0300 060 3900 or www.naturalengland.org.uk.

- 3 Where the removal of dead/dangerous tree(s) has taken place the owner has a duty under Section 213 of the Town and Country Planning Act 1990 (as amended) to plant a replacement tree. In this case the Council recommends a Sycamore (*Acer pseudoplatanus* sp.) be planted as a standard with a girth size of 14-16cms somewhere suitable within the garden. The exact variety planted is flexible, but it should be one that is recognised as being capable of attaining a mature height of at least 12-17m tall. The planting process should take into account the standards set out in BS8545:2014. The tree should be suitably staked and tied. The replacement should be planted by the end of the next planting season between the start of November 2023 and the end of March 2024. Failure to plant an appropriate replacement tree may result in the Council serving a Tree Replacement Notice.
