GRANT CONSENT FOR WORKS TO TREE/S UNDER A TREE PRESERVATION ORDER

Proposal:

IN AREA BESIDE MAYGROVE ROAD:

- 1 x Fraxinus excelsior (T17) - Lift crown to 4m.
- 1 x Populus nigra 'Italica' (T16) - Crown reduction by 25%, 6m.
- 1 x Betula pendula (T20) - Fell to ground level.
- 1 x Quercus rubra (T18) - Lift crown to 4m.
- 1 x Betula pendula (T29) - Fell to ground level.
- 1 x Acer pseudoplatanus (T37) - Fell to ground level.
- 1 x Carpinus betulus (T44) - Lift crown to 3.5m.
- 1 x Populus tremula (T48) - Reduce crown by 30%, 3m.

The Council has considered your application dated 07 June 2023 and decided to grant consent subject to the following condition(s):

Conditions and Reasons:

- 1 This decision is valid for 2 years from the date of this decision or until the work is completed, whichever is the sooner.

Reason: To allow the Local planning authority to monitor the completion and standards of the work.

- 2 All work shall be carried out in accordance with the relevant recommendations of British Standard 3998: 2010. (Recommendation for Tree Work)

Reason: To ensure the preservation of the amenity value and health of the tree(s).

- 3 Prior to the end of March 2024, replacement tree planting in accordance with the document entitled "Maygrove Walk Replacement Planting 2023/2335/T " shall be undertaken. The trees shall be planted and maintained in accordance with BS8545:2014.

Reason: In order to comply with section 206 of the Town and Country Planning Act 1990 (as amended).

- 1 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
