Front Garden:

T1: Mature Holm Oak: Approximately 12.00m: Reduce crown back to previous and most recent points, approximately 1.50m-2.00m. Thin crown density by approximately 20% throughout. General maintenance.

Rear Garden:

T2: Mature Holm Oak: Approximately 10.00m-12.00m: Reduce crown back to most recent reduction points, approximately 1.50m-2.00m. Thin crown desnity by approximately 20% throughout. Increase light levels, General maintenance.

T3: Mature Thuja: Located in No.5 and overhanging No.6: Lightly reduce overhanging lateral and sub lateral branches by approximately 0.50m. To help control encroachment.

T5: Mature Bay: Approximately 9.00m: Located in No.7 Terrace Grove: Reduce overhanging branches back to as near to the boundary as is practicable, Reduce crown height by approximately 1.50m-2.00m. To help separate from the Birch trees adjacent and increase light levels to No.5.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
