T1 - Ash Tree (located at the back of the garden), pollard back to the previous, approximately 3 meters. It is too close to the house and creates a blockage to the gathers. The red line on the picture shows the approximate cut we would like to.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
