There is a small dead Lime common tree in my private garden which needs felling including stump removal to ensure the tree and the roots don't cause any future risk of collapsing or subsidence to the building. This will ensure the single storey rear extension has a solid foundation without any risk. There is a history of subsidence caused by trees and its roots to the building. In December 2021, the tree roots outside the building busted Thames Water mains pipe causing a flood on the street and into our flats and our neighbour's flat.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
