Identification of Tree(s) and Description of Works

My clients would like to reduce the whole crown of 2x trees. T1 is a Roble beech to reduce by 1.5m height and 0.5m spread. T1 is a London Plane to reduce by up to 2.5m all over.

Firstly they would like to do a 1.5m Reduction on a Roble Beech (T1). This tree has once fallen over, and now re-rooted and grown again close to the building. The tree has a notable lean and growing very close to the building, we removed the ivy that smothered the tree to provide some peace of mind as it was swaying lots and the block directors/residents are worried that it will fall. The tree is also causing a fuss with the residents who's balcony's the tree is growing into and blocking light etc.

T1 is a London Plane tree. We would like to reduce by up to 2.5m. This tree is on the boarder of the estate, and over the years has started to damage the brick wall / fence where it is growing. They hope that after reducing the tree they can keep it a manageable size and re-build the wall / fence around the tree. It is also dropping lots of debris on the cars in the carpark below, and is growing near to the building.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - o showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)
